

MSM 25% FAST LANE TUITION WAIVERS

SDA Bocconi School of Management is making available **4 partial merit-based tuition waivers**, each covering 25% (**7,500** €) of the Master in Sutainability Management (MSM) total tuition fee, to 2025/26 MSM participants of the MSM Fast Lane Day (September 4, 2025) with an outstanding profile.

1. Beneficiaries and Requirements

The tuition waiver is available to MSM applicants with an outstanding profile that participate to the MSM Fast Lane, and they should meet the following requirements:

• They meet all admissions requirements for the participation in the 2025/26 MSM Program.

Only candidates who have submitted application within the deadline, producing all required documentation and have been admitted to the 2025/26 MSM Program are eligible for tuition waivers.

For Candidates Who Have Already Completed the Selection Process:

If you have already:

- Submitted a complete application
- Taken the required admission test (GMAT, GRE, or SDA Test)
- Completed the motivational interview
- Received a positive admission result or waiting for the final selection outcome

you do not need to complete any further steps to participate in the Fast Lane competition.

Your profile will be assessed based on the materials and evaluation from your existing selection process. You will be considered for the tuition waiver, if correctly flagged in your online application through the Admission Portal by the deadline of **August 25**, 2025, and results will be communicated by **September 8**, 2025.

The only thing you will be required to do during the Fast Lane Day is a brief conversation with the MSM Director or a MSM Faculty Member, or the Associate Dean of SDA Bocconi. The Fast Lane Day will take place online on **September 4th, 2025**, so please make sure to keep your schedule free on that date. You will receive a Microsoft Teams invitation in due time.

For New Applicants:

To be eligible for the Fast Lane interview and tuition waiver, you must submit a complete application by the deadline of **August 25, 2025**

Please note:

While the SDA Test (in case you opt for it over the submission of GMAT or GRE scores) is provided directly by the Admissions Office and will be sent in due time, you are responsible for ensuring that all other required documents are submitted by August 25, 2025 including the two reference letter forms. Make sure your referees complete them on time, as late/incomplete submissions will result in ineligibility for the Fast Lane Day.

- All eligible new applicants will be interviewed online on September 4, 2025 (Fast Lane Day)
 The interview time will be communicated in advance via email, and cannot be changed. You will receive a Microsoft Teams invitation in due time.
- Final selection outcomes and tuition waiver decisions will be communicated by September 8, 2025

2. Incompatibility and Loss of Tuition Waivers

The waiver can be combined with any other scholarship, award, or financial support for specialization courses by public or private organizations or companies if the total amount does not exceed the total registration fee. It can be combined with other SDA Bocconi Tuition Waivers available for MSM candidates if the total amount does not exceed the total registration fee.

The beneficiary must self-certify that the above-mentioned accumulation has not been exceeded. The beneficiary must comply with this condition for the whole duration of the MSM Program.

3. Lodging of Applications and Results

Applications for the tuition waiver must be sent through the online application portal in accordance with the deadline indicated in the table below. The assignment of the tuition waiver will be formally notified to the beneficiary by the Commission through an assignment letter, no later than the Communication of assignment date indicated in the table below.

Applications will be evaluated according to the following criteria: analysis of academic and professional record, analysis of the requirements indicated above, results of the MSM selection process. The decision is at the discretion of the Commission and it is final and unquestionable.

4. Acceptance of the conditions

Application for the tuition waiver involves full acceptance of the herein conditions. Under penalty of immediate withdrawal, the candidates must confirm their enrolment in the 2025/26 MSM as well as formalize their acceptance of all tuition waiver conditions with the Admissions office by the deadline indicated on the tuition waiver assignment letter.
