

# PARTIAL TUITION WAIVERS - EXECUTIVE MBA Modular 2025/27

SDA Bocconi School of Management is making available 6 merit-based tuition waivers of €19,000 to 2025/27 Executive MBA Modular candidates with an outstanding profile.

# 1. Beneficiaries and Requirements

The tuition waivers are reserved for candidates who can demonstrate an outstanding personal, academic, and professional background and who meet the following conditions:

- Fulfill all the admission requirements for the Executive MBA Modular Program;
- Have not received any other financial support covering the program tuition fee, or scholarships which, if combined with this waiver, would exceed the tuition fee.

Only candidates who applied, producing all required documentation, and have been admitted to the 2025/27 Executive MBA Modular Program are eligible for tuition waivers.

# 2. Incompatibility and Loss of Tuition Waivers

The waiver can be combined with any other scholarship, award, or financial support for specialization courses by public or private organizations or companies if the total amount does not exceed the total registration fee.

The beneficiary must self-certify that the above-mentioned accumulation has not been exceeded. The beneficiary must comply with this condition for the whole duration of the Executive MBA Modular Program.

As beneficiaries of a financial grant awarded on merit basis, participants must prove high academic performance during the Executive MBA Modular Program to preserve the right to the tuition waiver, according to a minimum performance limit set by the School. The right to the tuition waiver is subject to the regular completion of the 2025/27 Executive MBA Modular program as indicated in the 2025/27 Executive MBA Modular Rules.

#### 3. Lodging of Applications and Results

Applications for the tuition waiver must be sent through the <u>online Application portal</u> in accordance with the deadlines indicated in the table below. Tuition Waiver Applications must include a <u>Motivation Letter</u>.

The assignment of the tuition waiver will be formally notified to the beneficiary by the Commission through an assignment letter, no later than the Communication of assignment dates indicated in the table below.

**Tuition Waivers Application Time Frames and Communication of Results:**

Deadline: July 1 <sup>st</sup> , 2025 – June 3 <sup>rd</sup> , 2025	Within September 8 <sup>th</sup> , 2025 – July 21 <sup>st</sup> , 2025
Deadline: August 25 <sup>th</sup> , 2025	By the beginning of the Program

Applications will be evaluated according to the following criteria: analysis of academic and professional record, analysis of the requirements indicated above, results of the Executive MBA Modular selection process. The number of assignments to applicants will not be equally divided amongst the 2 rounds. The final percentage of awarding for each round is at the discretion of the Commission and their decision is final and unquestionable.

# 4. Acceptance of the conditions

Application for the tuition waiver involves full acceptance of the herein conditions. Under penalty of immediate withdrawal, the candidate must confirm their enrolment in the 2025/27 Executive MBA Modular as well as formalize his/her acceptance of all tuition waiver conditions with the Admissions office by the deadline indicated on the tuition waiver assignment letter.
